Navigating Medicare

State Health Insurance Assistance Program (SHIP)

SHIP is a federally funded, nation-wide program that offers free, objective, and local one-on-one Medicare counseling and assistance to Medicare eligible individuals, their families and caregivers.

Senior Medicare Patrol (SMP)

The Senior Medicare Patrol (SMP) is a national program for people with Medicare of all ages. SMP is administered by the Administration for Community Living.

PROTECT yourself against Medicare fraud

Protecting your personal information is your best defense against health care fraud and abuse.

DETECT potential fraud, errors, and abuse

Knowing how to spot suspicious activity can help you stop health care fraud and abuse in its tracks.

REPORT suspected fraud, errors, and abuse

If you suspect you have been a target of fraud, report it. This will help you and others at risk for health care scams.

Medicare Improvements for Patients & Providers Act (MIPPA)

MIPPA is a federally funded program that provides information and application assistance to low-income Medicare eligible individuals who may qualify for cost saving programs and provides outreach to promote wellness and disease prevention.

Two valuable programs that MIPPA can assist with are:

- Low Income Subsidy (LIS) The LIS program, also known as "Extra Help", provides assistance to Medicare Part D beneficiaries in paying for their monthly prescription drug costs.
- Medicare Savings Programs (MSP) These benefits, available through
 the state Medicaid agency, help
 beneficiaries with low incomes pay
 for their Medicare costs.
